Types of Information Collected for Online Transactions and How It Is Used

The Edith Macias Van Southern California Chapter (EMVSC CA-7) of the Women Marines Association (WMA) is pleased to provide information to its members and website users about its online privacy policy for merchandise sales. Please be assured that WMA uses its best efforts to protect the privacy of visitors to this Web site.

EMVSC Chapter CA-7 WMA values your privacy. We will never lease, sell, give, or otherwise disseminate your email address or other confidential information to any party. We will at times send you information to keep you informed as to membership & newsletter billings, status reports, or policies that may affect you. Please be assured that EMVSC Chapter CA-7 WMA uses its best efforts to protect the privacy of visitors to this Web site.

WMA gathers personal information, such as first and last names, home addresses, e-mail addresses, phone numbers, etc., only when voluntarily submitted by you. Some types of transactions where information may be collected from you include purchasing WMA merchandise, applying for membership, or renewing membership. Personal information will be collected from you in order to process these transactions only. With your permission, we will use personal information collected from you to process your transaction only. ***No information collected electronically is retained by EMVSC Chapter CA-7 WMA using any of our online forms*** (once the online form has been completed by you, printed out and closed, any data rendered by you is reset on the form and permanently deleted once the form is “closed”).

Sharing of Personal Information

Companies may be engaged by EMVSC Chapter CA-7 WMA to perform a variety of functions, such as assisting with merchandise payment, dues payment, providing technical services for our Internet sites, etc. Currently EMVSC Chapter CA-7 WMA does not employ any of these services; however, it may at some point in time. When these services are made necessary, EMVSC Chapter CA-7 WMA will notify its membership and other interested parties of those services rendered and any impact it may have regarding your personal information held by EMVSC Chapter CA-7 WMA. Such companies may have access to personal information if needed to perform certain functions (mailing lists for our newsletter, as an example). However, these companies may use such personal information only for the purpose of performing that function and may not use it for any other purpose. Other than as provided in this privacy policy, EMVSC Chapter CA-7 WMA does not sell, transfer or disclose personal information to third parties.

WMA reserves the right to use or disclose any information as needed to satisfy any law, regulation or legal request, to protect the integrity of the site, to fulfill your requests, or

to cooperate in any law enforcement investigation or an investigation on a public safety matter.

Cookies

“Cookies” are pieces of information that an Internet site transfers to an individual’s hard drive for record-keeping purposes. Cookies allow a certain Internet site to remember important information that will make your use of the site more convenient. Like most Internet sites, EMVSC Chapter CA-7 WMA uses cookies for a variety of purposes in order to improve your online experience. For example, we may track the total number of visitors to our site on an anonymous, aggregate basis. We may also employ cookies so that we remember you when you return to the site. We may associate personal information with a cookie file in that instance.

Use the options in your Internet browser if you do not wish to receive a cookie or if you wish to set your browser to notify you when you receive a cookie. Click on the “Help” section of your browser to learn how to change your cookie preferences. If you disable all cookies, you may not be able to take advantage of all the features of this Web site.

Links to Other Sites

We may offer links to sites that are not operated by EMVSC Chapter CA-7 WMA. If you visit one of these linked sites, you should review their privacy and other policies. We are not responsible for the policies and practices of other companies.

Internet Merchandise Policy Changes

From time to time, it may be necessary for WMA to change its internet merchandise policy, so we suggest that you check here periodically. Changes will not be retroactively applied and will not alter how we handle previously collected information.

Our refund / cancellation policy

Membership Refunds will not be granted for payment of membership dues to the Women Marines Association or EMVSC Chapter CA-7 WMA. Merchandise Refund/Exchange

If you are not completely satisfied with your merchandise, items may be exchanged or refunded. Items must be returned within 30 days from the date that we shipped them to you. Refunds will be issued 5 -7 business days after we receive returned items. Shipping and handling charges and insurance cannot be refunded. Items that have been personalized cannot be refunded or exchanged. Be sure that your personalization is correct.

When exchanging merchandise, please include new product description(s) and numbers(s), and shipping and handling charges for your new order.

We will not charge shipping on items exchanged due to manufacturer defect.

Cancellations
