Academic requirements are a minimum combined SAT score of 1600 or a ACT score of 22 *AND* a GPA of 3.5 or higher. He or she must be a 2012 graduate of a North San Diego County high school and must be a legal resident of the United States. Military affiliation is not required.

The applicant must complete the enclosed application. The form may be photocopied. It lists the items necessary to complete the application.

The completed application must be mailed to the Scholarship Committee Chairman of the **Edith Macias Vann Southern California Chapter of the Woman Marines Association** and **POSTMARKED NO LATER THAN MARCH 25, 2012.**
